# NORTHERN PLAINS CLASSIS 14th Annual Meeting \* March 29-30, 1999 First Reformed Church, Aberdeen, South Dakota

#### I. SERVICES

The 14th Annual Spring Meeting of the Northern Plains Classis convened on Monday, March 29, 1998 at the First Reformed Church of Aberdeen, South Dakota at 1:00 P.M. with a devotion. Rev. Maynard Koerner led the Classis in devotion, using Isaiah 40 as the text.

The Classis met for a worship service with the congregation of the First Reformed Church on Monday evening at 7:30 P.M. Rev. Darrell Kingswood conducted the worship service and Rev. Michael Voytek preached a sermon titled, "The Justified Shall Live By Faith," using Habakkuk 2:2-4 as the sermon text.

The Classis opened its session on Tuesday, March 30 with devotions. Rev. Robert Davis led the Classis with a devotion from I Timothy 5:17 and Romans 13:1-7.

#### CANDIDATES AND CREDENTIALS

#### **Esteemed Brothers:**

The Candidates and Credentials Committee dealt with three items this past year, namely the matter of stated supply status of Dr. Grael Gannon, the progress of Mr. Tracy Gruggett as a student under care of Classis, and the progress of Captain Jim Synder as a student under care of Classis.

Concerning Dr. Grael Gannon: the committee (Rev. Voytek, Rev. Van Stedum, Rev. Syms) met with Grael at his home (present also was Elder Alwin Rau) concerning the mandate given at the last Classis meeting, i.e. "to discuss his submission to the Creeds of the Church," p.33 of the 1998 Abstract. Dr. Gannon presented the committee with 6 pages of quotes from the three forms of unity which addressed the areas of concern. He was reminded of the present oath for officebearers which he is now under and that he is obligated to teach and defend and reject all errors in conflict with the creed. In the areas of dispute he stated that "these were not settled convictions" but "hypothetical possibilities". It is his position that no one can receive salvation except through the grace of God in Jesus Christ. He considers his views to be in agreement with the creeds.

The committee recognizes that he is presently an elder in the Kassel Reformed Church. As such it is proper for him to conduct worship services. We are not recommending official status as "stated supply".

Concerning Mr. Tracy Gruggett: Mr. Gruggett is completing his first year of Seminary training at Westminster Theological Seminary in California. It has been a difficult but exciting year for him and his family. He is doing well in Seminary with exception of his first semester in Hebrew (that is now improving) He is attending a United Reformed Church in Escondido. Prior to going to California he conducted worship services in several of our churches and has a real love for the gospel ministry and for the study of Theology. We would encourage each of you to remember to pray for him. He is requesting that Classis consider diaconal aid for him. He submitted an annual progress report and a transcript of his grades. He is requesting aid for tuition of \$7,920. This is for 36 units of study at an approximate cost of \$220. each.

Concerning Captain Jim Synder: Mr. Snyder continues in the Air Force being stationed at the Minot Air Force base. He has been elected as an elder in the Harvest Reformed Church of Minot. We should have a written report from him at Classis.

#### **HOME MISSIONS**

Fathers and Brethren:

The Home Missions Committee of the Northern Plains Classis has been given the responsibility to consult with and report on the developments in two congregations that are receiving Benevolent Aid from Synod. These are the **Hope Reformed Church**, Pierre, South Dakota, and **Harvest Reformed Church**, Minot, North Dakota.

We also have received a recent report from our only Home Mission congregation, **Covenant Reformed Church**, Watertown, South Dakota. Lastly, we are happy to report that we now have a contact family in **Fargo**, **North Dakota**, which is very committed to promoting the establishment of a Reformed Church in that city.

#### I. Hope Reformed Church, Pierre, SD.

On January 5th, 1999, the NPC Home Missions Committee met with the Consistory of Hope Reformed Church to discuss their progress in the last year. Worship, Bible Studies, and quarterly fellowship gatherings are well attended. The congregation has been through some trying times in 1998, with one death, another member suffered a heart attack, and one of their beloved elders was diagnosed with cancer. We were requested by the Consistory to meet with them, as there were questions about how to proceed to the point where Benevolent Aid would no longer be required. The HMC and the Consistory discussed these matters at length, and noted that the intention of Hope Reformed Church was not to continue receiving assistance indefinitely, but still needed the help of Synod and Classis. One family has moved away, however, the giving in the congregation was 10% higher in 1998 than that of the previous year. The church is using a direct mailing to newcomers as a means of outreach. There have not been many visitors from the Pierre vicinity. The NPC HMC believes that the Hope Reformed Church is doing everything possible to be diligent in the work, and are making efforts to develop outreach into the community. The Consistory is concerned to eliminate the debt on the parsonage as quickly as possible.

#### II. Harvest Reformed Church, Minot, ND.

On January 19th, the NPC Home Missions Committee traveled to Minot to meet with the Consistory of Harvest Reformed Church. The worship services of the church are well-attended, with an average of 41 present each Lord's Day. They hold a monthly fellowship dinner which is fairly well attended. The Consistory noted that the practice of inviting others to church functions needs improvement. Over the past year the congregation has seen a net increase of 4 members. One of the greatest concerns presently is the purchase of new property on which to build a church meeting place. Real estate prices are rather high in Minot, with assessments costing as much as the land. The church presently meets in the Parker Center in downtown Minot, and the congregation has adapted well to this temporary location. There was a commendable increase in giving, up 25% from the previous year. The Pastor and Consistory are very committed to this work, and are concerned that the enthusiasm for the work of the church be increased.

#### III. Covenant Reformed Church, Watertown, SD.

We did not meet with the Consistory of the Watertown church, but have been in regular contact with Pastor Maynard Koerner, who has kept us up-to-date on developments in the congregation. Covenant Reformed has not seen any significant growth numerically in the last year, but desires to stay the course and seek God's blessing on their efforts in the church-gathering work of our Lord. We refer you to the report submitted by the Covenant Reformed Consistory.

## IV. Fargo, North Dakota

Our interest in pursuing the work of Home Missions within the bounds of the Northern Plains Classis has logically led us to the larger cities of North and South Dakota. We have now made contact in Fargo with a young man and his family who are members of the OPC. Rev. G. Syms had planned to meet with them in January but could not due to an illness in the Pederson family. Rev. G. Syms and Rev. M. Koerner met with the Pedersons at their home on February 19th, 1999. Mr. Larry Pederson, his wife Amy, and their children could very well be instrumental in gathering people together for meetings, Bible Studies, and worship services in the near future. We believe that there is potential here for reaching out to those who are either unchurched, or who have no Reformed background. We also have the encouragement of the OPC as we pursue this field of home mission work. God

willing, we plan to conduct an initial Bible Study in Fargo on the evening of March 21st with four families enlisted by Mr. Pederson.

*In summary*, we believe it is imperative for the congregations of the NPC to put themselves in an aggressive mode for doing mission work. It is also important that we do not do so out of a sense of desperation because of the decline of the older congregations, but out of a sincere desire to fulfill the mandate of the Great Commission. Please pray for our prospective work in Fargo, as it must be pursued from great distances, and developed by pastors who are already extremely busy. Your ideas and suggestions in this matter would be most welcome.

- 4. That the NPC overture Synod for Benevolent Aid in the amount of \$3,000.00 for Harvest Reformed Church for 1999.
- 5. That the NPC budget \$8,325.00 for Covenant Reformed Church, Watertown, SD, for 1999.
- 6. That the NPC budget \$4,160 for Home Mission work in Fargo, ND, for 1999.

#### **CAMP COMMITTEE**

Joint South Central Classis & Northern Plains Classis Heidelberg Youth Camp Committee Report

The Heidelberg Youth Camp Committee Meeting met by Conference Call, February 26, 6:00 PM. Members present: Elder Roger Gallimore, Rev. George Horner, Rev. Robert Davis, and Rev. Darrell Kingswood.

- 1. Highlights of the 1998 finance report showed a net gain of \$688.89. However, from that amount \$250.00 is projected to be drawn for another 2 issues of HYC Fire. There was a memorial gift of \$1,000.00 received for the purpose of equipment purchases. From this gift \$855.99 Was spent for an overhead projector, cart, screen, overheads for contemporary songs, and overheads of hymns from the new Trinity Hymnal.
- 2. The proposed 1999 budget includes a 5 percent increase in camper fees up to \$98 per camper. The greatest reason for this increase is that Camp Bob Marshall is now required to charge a 6 percent sales tax on outside users of the camp. Hence, facility use projections are up 6 percent.

Other items show a projected increase of an average of 5 percent. Last year HYC Fire was included in the camp budget. For 1999 it has been taken out and a recommendation that HYC Fire be funded in the amount of \$250.00 from South Central Classis and \$250.00 from Northern Plains Classis. Although camp is still a key part of each issue, the scope of the publication is broadening out to young people who are not part of the camp.

3. The theme for the 1999 camp is **Walk the Talk.** HYC has been emerging as a vehicle that focuses on supporting and teaching a Christian Worldview for our covenant youth. It is the opinion of the camp director and the committee that today's covenant youth in day-to-day activities are not all that different from worldly youth. The theme is designed to help our young people develop an arsenal of which to defend and to live the Christian faith. The lesson topics will be:

**Thinking the Walk** - This is the overview lesson given on the first evening for the purpose of holding our minds captive to Biblical thoughts and that all our actions are an outward display of that which is inward. Living a Christian life is not to be compartmentalized. Rather, it is to be expressed in all our thoughts, words, and deeds.

Walking the Talk With Friends How we interact with friends, the friends we choose, and the activities surrounding our friendships all express our faith. This lesson will challenge the campers to consider the godliness of these relationships.

**Walking the Talk With Money -** It is noted that few of our covenant youth are taught how to handle money. Yet, this is a very real and practical means of demonstrating faith. Do we really believe this is God's money, that we are stewards of that which God has given us, and that this includes giving back at least 10 percent? This course helps us to put our money where are thoughts ought to be.

**Walking the Talk With Family** ~ The lack of respecting authority is a key issue in our culture today. Humanly speaking, it starts with the family. This lesson deals with what God commands regarding our respect for parents and how that carries forward into society. This lesson will also cover the duties and responsibilities of young men and women as they prepare for marital roles.

Walking the Talk With Learning - How do we discern the truth in a world that is openly hostile to the truth? The vast majority of our covenant youth are educated in the public school system. To be sure there are many godly teachers in the public schools, yet, it is still a system based on a secular humanistic worldview. This lesson covers identifying different worldviews that are typically presented in the classroom and in the media and how to discern these presentations with the truth of God's Word.

Walking the Talk With God's Will - A common question of young people is, "How do I know what God wants me to do?" This lesson will distinguish between God's sovereign will and God's revealed will and the importance of following God's commands in all life's decisions, big or small.

Walking the Talk With Time - I don't have time to . . (fill in the blank). How often have you heard that said from our covenant youth. Time choices are greater today than at any other point in history. How do we choose to spend our time? What are our priorities? Time, like money, is a gift given by God and of which we are to use wisely. This lesson provides practical tools in discerning wise use of time.

- 4. The worship service was discussed. There will be 10-15 minutes of praise, hymn, and Psalms sung prior to the worship service. The service itself will follow the order of Worship as suggested in the Directory of Worship and will include the Apostle's Creed in the first service, reading of the Law in the second service, and the Nicene Creed in the final service. Sermon texts will include: 2 Corinthians 10:5; Romans 12:1,2; Ephesians 4:17-23. There will be an offering taken at each worship service. It is intended for each year that the offering go to support a missions project. The recipient of the offering this year will be Watertown.
- 5. There will be a personal devotional booklet put together for the campers that focus on the theme.
- 6. There will be a counselor's handbook put together to help counselors prepare for the week of camp. The handbook will walk through each component of camp and will include guidelines for activities such as talent night, devotions, etc. A few skit books will also be purchased to help counselors for talent night.
- 7. The camp will again meet at Camp Bob Marshall. The dates are July 26-30. Camp Bob Marshall has also been reserved in 2000 for July 24-28.
- 8. There are only a few minor changes in the camp schedule. The last two years the seniors were given more freedom with no curfew. Late nights proved to be a good time of campfire learning and of tired people in the morning. This year a senior curfew of 1:00 AM will be in effect as a compromise to extended visiting and getting some sleep.

#### CHRISTIAN EDUCATION COMMITTEE

Dear Brethren,

Your Committee on Christian Education has three matters on which to report and make recommendations.

- 1. The Northern Plains Chronicles was published by Rev. Jones every two months this past year. His news items are based on the news he finds in the weekly bulletins which are sent to him from the Classis churches. Some of the churches have more "newsy" bulletins than others. We hope that the members find the newsletter of interest. Rev. Jones is willing to continue as editor for another year.
- 2. We have discovered the whereabouts of the Classis video library. It has been in the care and keeping of Rev. M. Koerner. The Hope Reformed Church in Pierre has the space to house the few videos which are the property of the Classis, and Rev. Jones has offered to be the librarian and handle any requests that members may have to borrow its videos. A listing of the videos will be made available via the NP Chronicles. We hope to add more videos to the library. Anyone who wishes to donate a video to the library may contact the librarian about the offer. Of course, we want only videos of general Christian interest for the library.
- 3. It has come to our attention that the annual Family Retreat at the Cross Roads Range, which is an unofficial activity of members of our Classis should perhaps be under the oversight of a Classis Committee, probably the Christian Education Committee. We deeply appreciate the labors of Darrell and Julie Bentz of Artas who were the main organizers of this family retreat. The retreat has been held the past several years in northern North Dakota. We are suggesting that in the interests of proper order and oversight the retreat probably should not be an independent entity separated from Classis authority. The Bentzes are in agreement with this proposal.

#### Recommendations:

- 4. That Darrell and Julie Bentz and all who have helped with the Family Retreat be commended for their efforts.

This has been a fairly quiet year for the Northern Plains Classis. With the ordination and installation services of pastors Michael Voytek and Darrell Kingswood all of the pulpits are filled. All of the pastors report that the word of God has be regularly preached and taught in their congregations. For all of this we are grateful and praise our sovereign God. The Executive Committee, especially the Clerk, are also happy to have had such a quiet year.

The report from Minot, ND is quite encouraging. There seems to be some growth and renewed excitement among the congregation. We trust that they will soon find a piece of property to build a place of worship on. We also trust that they will be able to sell the current church property. The congregation in Pierre, SD is also very busy seeking ways to reach the community with the Gospel. We trust that the strong efforts of preaching and teaching will be used by the Lord to bring a large harvest. Both of these congregations are receiving Synodical and Classical aid. They are desirous of becoming self-supporting as soon as possible. We trust that the efforts of the Home Missions Committee in providing oversight to these congregations will be beneficial. May God be pleased to bless these congregations.

Last year we noted that the congregation of Upham, ND was in the process of dissolving. This process has been completed, with the exception of some legalities that are still in process. The Missions Committee has also been pursing the possibility of beginning a mission work in Fargo, ND. At this Classis meeting we will be discussing the possibility of beginning a bible study on a regular basis. May the Lord bless these efforts.

Mr. Grael Gannon, a elder of the Kassel Reformed Church of Denhoff, ND continues to fill the pulpit there. Student Tracy Gruggett has completed his first year of seminary at Westminster Seminary in California. Student Jim Snyder has not yet begun seminary training. Retired pastor Norman Jones reports continued struggles with his health. However, he is able to continue with some ministerial labors. He is faithfully editing the Northern Plains Chronicles. We pray that God will continue to provide for his health.

I informed them that we were pursuing the possibility of a mission work in Fargo, ND.

I appreciated the opportunity to meet and visit with the men of the Presbytery. I was warmly received and extended every courtesy.

## Report of the Delegate to the 1999 Spring Meeting, Presbytery of the Dakotas, OPC

Esteemed Brethren and Fathers.

Your servant attended the spring meeting of the Presbytery of the Dakotas (POD) which was held in Carson, North Dakota on March 23-24, 1999. The warmth, acceptance, and fellowship of the brethren was of great encouragement.

The POD is facing the same challenges that we are facing, that of declining rural churches due to declining rural populations. They are addressing this situation in the same way as we are, that is by focusing on planting churches in larger urban areas within their bounds. They are in the process of planting churches in Colorado and Salt Lake City, Utah. we can learn much from the work in Ft. Collins. After 5 years of struggle in attempting to plant a church, they are experiencing very healthy growth. This past year they have grown from 20 to 40 people in attendance.

Your servant was invited to address the Presbytery and he focused on their commitment to faithfulness to the truth He also exhorted them from Psalm 133 to strive for the unity of the church, both within their own churches as well as with their relationship with sister churches such as the RCUS.

Your servant was invited to participate in the ordination exam of a young man who is now the pastor of the church in Hamill, SD. I was impressed by the thoroughness of the exam and the quality of the answers given by the examinee. There were also a number of judicial matters addressed by the Presbytery including a complaint from a church in Colorado and charges against a minister.

#### **APPENDICES**

## THE STANDING RULES OF THE NORTHERN PLAINS CLASSIS

1. The Classical dues shall be due on the first of September and are to be paid not later than the 30th of September of the current year.

- 2. The parochial reports and statistics shall be forwarded two weeks before the spring session; the parochial reports to the President of the Classis and the statistics to the Stated Clerk two weeks before the session of Classis.
- 3. The writ of certification for delegate elders shall be forwarded to the Stated Clerk two weeks before the session of Classis.
- 4. The Standing Rules shall be read during the session of Classis.
- 5. If pastors, elders, and members of congregations request information from the Executive of Classis concerning constitutional matters and procedures, as provided in Article 91, the answer shall, if the request is in order and in written form, be presented in written form and relevant only to the item in question.
- 6.a. If a pastor and his elder drive to classis separately, they shall be paid 12 cents both ways; 6.b. If a pastor and his elder come in the same car, the one driving is to get 20 cents per mile and the rider is to get 4 cents per mile:
- 6.c. If there is but one delegate driving he is to get 20 cents per mile, and if a man travels in behalf of classis business he is to get 20 cents per mile;
- 6.d. When distance and time require travel on public transportation to classis, or for classis business, they shall be granted full fare.
- 7 Travel reimbursement shall be paid only to those delegates whose congregations have paid the Classical dues in full to the classis Treasurer, and those delegates who have attended all sessions or have been properly excused by Classis.
- 8. The monies sent to the Treasurer shall be made out in check form to "Northern Plains Classis," and shall be designated for which fund and how much for each fund.
- 9 The President of Classis shall receive one hundred dollars (\$100.00), the Stated Clerk shall receive two hundred fifty dollars (\$250.00), and the Treasurer one hundred dollars (\$100.00) for the Classical year.
- 10. Nominations for all officers of Classis shall be made by secret ballot. All names appearing on the nominating ballot shall be candidates, and if there is not an election on the first ballot, only the names with the two highest totals of votes shall be candidates until there is an election.
- 11. The worship services of Classis shall be prepared by the Executive Committee, and these proposed services shall be circulated before Classis.
- 12. Overtures sent to the Stated Clerk of Classis four weeks in advance of Classis shall be circularized, but overtures may be submitted to Classis at any time.
- 13. Every charge that will not have an elder delegate at the yearly Spring meeting of Classis shall, before the date of the meeting, send in the answers to the questions placed before the elders according to Article 81 of the Constitution. This copy shall be signed by all the elders of the charge, and sent to the Stated Clerk.

- 14. The reports and recommendations of the Permanent and Special Committees of Classis shall be completed and mailed to the Consistories of all the Churches two weeks before the Spring Meeting of Classis. Parochial reports from all Ministers and Licentiates are to be sent to the President at least two weeks before the Spring meeting of Classis. Excuses for these requirements are to be made by written request to the Executive Committee of Classis by the chairman of the committee involved, at least two weeks before the meeting of Classis.
- 15. It shall be the practice of the Classis before ordaining candidates for the ministry and before installing ordained ministers from other denominations, to require no less than a six month internship for them under the supervision of a pastor of the Classis who has served in the Reformed Church in the United States for at least five years. During this internship particular emphasis shall be placed upon learning the peculiarities and practices of the RCUS. This internship requirement may be fulfilled either before or after the candidate has received a call or is licensed.
- 16. All documents submitted to Classis be written on sheets of paper 8.5 inches wide and 11 inches long.
